All forms of Military Identification must be current, valid and non-expired.
Only one (1) certificate may be submitted per military ID.

First and last name of qualified purchaser must be the same on military ID, rebate certificate and warranty registration (PDI). If registering the vehicle in the name of a business, evidence of business ownership must be provided. Business ownership documentation must match the first and last names provided on proof of military identification submitted.

First Responder Savings Bonus Eligibility: All active-duty first responders, paid or volunteer, including firefighters, law enforcement, paramedics and emergency medical technicians (those who arrive first on the scene), must show valid identification indicating active service.
